


# UTILITIES REGULATORY AUTHORITY

## MONTHLY ENERGY MARKET SNAPSHOT FOR January 2014



Electricity sources – Jan 14

The graphic on the left shows how electricity was produced in Vanuatu in January. 67% was generated from Diesel, followed by Copra 17%. Hydro and Wind contribute for 9.1% and 6.6% respectively. Solar generated an additional 0.2%.

### Electricity generation by area – Jan 14

The following table shows how much diesel was used to generate electricity in each area, and the total amount of electricity generated for the month. The bottom part shows how electricity was generated in each area from each different source.

### Fuel and energy price index evolution

This table links the monthly change of the fuel price index, litres used and the electricity price index in Vanuatu. Both indexes for fuel cost and electricity price started with 100pt base in June 2011.
